1	Application for granting financial support scholarship, registered and completed by the student			
2	Income declaration on own responsibility, completed and signed by the student			
3	Certificates showing the net income earned in the last 12 months before the beginning of the academic year by family members employed (parents, spouse, student, siblings)			
4	Payment slips of allowances, benefits, or other special support from the state, for the last 12 months before the beginning of the academic year			
5	Pension slips or certificates from the last 12 months before the beginning of the academic year

14	Certificates issued by local financial authorities (ANAF) showing the income obtained by family members and the student from personal sources or authorized activities, according to the law			
15	Certificate issued by the City Hall of domicile showing the family income obtained from agricultural activities, according to Law no. 227/2015 on the Fiscal Code, with subsequent amendments			
16	Married students must present: student certificate of the spouse (if applicable), copy of marriage certificate, copy of the child(ren)'s birth certificate(s), declaration of responsibility stating that no other income is obtained except those declared, and parents' declaration that they do not support them financially			
17	Certificate issued by the year secretary attesting the fulfillment of the conditions for granting scholarships, according to the Student Scholarship Regulation			
18	Social inquiry, if the student falls into the following situations: 1) No member of the family (including the student) has any income; 2) At least one parent works or resides abroad; 3) At the request of the faculty scholarship committee			
19	Other supporting documents regarding incomes, as provided in Annex 3 of the Student Scholarship Regulation (if applicable)
